Disclosure of notes on shareholding pattern- Tata Sons Private Limited i.e. TSPL holds 31.90% of Equity Shares of the Company. TSPL, being a Core Investment Company registered with the Reserve Bank of India, is exempted from the Companies (Significant Beneficial Owners) Rules 2018, as amended from time to time, on investment made by them. Other than TSPL, no shareholder holds 10% or more of paid-up Equity share capital of Company.

Disclosure of notes in case of promoter holding in dematerialized form is less than 100 percentage- The difference of 50 shares of Rs 10 each which are not held by promoter in dematerialised form is on account of Writ Petition no 1478 of 1995 filed by Rajnandini Pachasia in the High Court of Calcutta. The matter is pending in the Court and the final order is awaited. Hence Tata Sons Private Limited has not been able to dematerialise the said 50 shares

Disclosure of notes on shareholding pattern for company remarks explanator

- 1) Consequent to a Scheme of Arrangement sanctioned by the Hon'ble National Company Law Tribunal, 10,060 equity shares of Tata Chemicals Limited held by TMF Business Services Limited (Formerly Tata Motors Finance Limited, Promoter Group) have been transferred to Tata Motors Finance Limited (Formerly Tata Motors Finance Solutions Limited). Accordingly, as on September 30, 2024, Tata Motors Finance Limited (Formerly Tata Motors Finance Solutions Limited) has been reported under Promoter Group holding 10,060 equity shares of Tata Chemicals Limited. The Company has reported NIL shareholding against TMF Business Services Limited (Formerly Tata Motors Finance Limited) within the Promoter Group.
- 2) Pursuant to the scheme of arrangement between Tata Coffee Limited, TCPL Beverages & Foods Limited and Tata Consumer Products Limited, 150 shares of Tata Chemicals Limited held by Tata Coffee Limited have been transferred to Tata Consumer Products Limited. The Company has reported NIL shareholding against Tata Coffee Limited within the Promoter Group.
